Puppy Health and Sales Contract

The Seller, Northwest Havanese, and the Buyer, _____ hereby agree as follows:

1. The Seller hereby sells to the Buyer, for the amount of \$ _____ which is hereby acknowledged, a (male/female) _____ puppy born on _____ of the Dam
_____ Out of the Sire

All funds must clear 1 week before pick up of the puppy.

___ **A.** Limited Registration. Never to be used for breeding purposes. We suggest instead of neutering or spaying, you use the procedures of vasectomy or removal of uterus but not ovaries. See mercolahealthypets.com under the subject "The damaging effects of spaying and neutering on dogs." This is entirely left up to the discretion of the buyer as to what procedure they want to do.

___ **B.** Full AKC registration. The puppy seems to be of breeding/show potential at the time of purchase. The breeder does not guarantee that the Puppy purchased will be successful in breeding/show program. Full AKC registration gives the buyer the right to breed/show the puppy purchased when it becomes of breeding/show age. The Seller highly recommends that when the puppy is of breeding age that it be examined by a Veterinarian to be determined if the dog is of good enough health and quality to whelp or sire puppies. Buyer may not breed bitch without the exclusive right of seller to approve of stud to be used. Without this permission, seller has right to claim bitch and any puppies born.

2. The Seller will provide the Buyers with necessary application papers.
3. The Seller guarantees that the puppy is in good health of the date of purchase. The Buyer has 72 hours to have the puppy checked by a veterinarian of their choice. If your Veterinarian finds the puppy not healthy, you may return the puppy along with the Veterinarian statement for a full refund or a replacement puppy. Please note that the Seller is not responsible for any Veterinarian/shipping costs. The Seller guarantees the puppy for the term of **2** years against life threatening genetic defects and will replace the puppy after receiving a full Veterinarian report stating the exact defect. In event of the puppies death a necropsy must be performed to determine the cause of death. This guarantee does not cover hypoglycemia, a condition that can be caused by stress, missing meals, excessive playing or exercise. The Buyer has been fully informed about this

condition; its causes and treatments.

We strive to breed good temperament in our dogs but because the Seller has no control over the training of the puppy, once it is placed in its new home, the Seller cannot guarantee its temperament will be of positive quality.

4. The Buyer shall maintain the puppy in good condition, including adherence to a regular immunization and worming schedule, heart worm preventative, good diet, and a clean and safe environment.

5 The puppy shall **AT NO TIME BE GIVEN AWAY OR SOLD TO A THIRD PARTY UNLESS APPROVED BY BREEDER .**

It shall be returned to seller without monies exchanged, no questions asked.
